Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), 1 2 general counsel to Krista L. Freitag (the "Receiver"), the Court-appointed receiver for ANI Development, LLC, American National Investments, Inc. ("ANI"), and 3 their respective subsidiaries and affiliates (the "Receivership Entities"), hereby 4 submits this Ninth Interim Application for Payment of Fees and Reimbursement of 5 Expenses (the "Application"). This Application covers the six-month period from 6 January 1, 2022 through June 30, 2022 (the "Application Period"), and seeks 7 8 approval of \$552,586.50 in fees and \$42,642.24 in expenses, and an order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred 9 (\$442,069.20) and 100% of the expenses incurred (\$42,642.24). 10

11 The Receiver and Allen Matkins have previously filed fee applications on a quarterly basis. This fee application, however, covers a six-month period in order 12 to catch up a bit, such that, going forward, fee applications can be reviewed closer in 13 14 time to when the work they cover was actually performed.

#### 15 I.

#### **INTRODUCTION.**

16 This equity receivership involves a large, complex, and wide-ranging group 17 of enterprises and assets associated with the Ponzi scheme that is the subject of the 18 Complaint filed by the Securities and Exchange Commission. The Receiver was 19 appointed on September 3, 2019. Dkt. 6.

The ordering appointing the Receiver confers broad duties, responsibilities, 20 21 and powers upon the Receiver, which are designed to allow her to secure, preserve, 22 and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of the Receivership Entities' financial transactions, investigate and 23 recover sums transferred to third parties, review and analyze investor and creditor 24 25 claims, and maximize the amount ultimately available for distribution to investors and creditors. Id. The Receiver determined that experienced and qualified counsel 26 27 was critical to the performance of her duties and obligations under the Appointment Order due to the size and complexity of the receivership estate. Accordingly, the 28

Receiver engaged Allen Matkins to assist with legal issues facing the receivership
 estate.

This Application should be read in conjunction with the Receiver's Tenth and
Eleventh Interim Reports and Recommendations, filed on February 24, 2022 and
June 14, 2022 (Dkt. 755, 816), which describe in detail the Receiver's activities
during the six-month Application Period.

7 This Application seeks approval of \$552,586.50 in fees for a total of 1,265.40
8 hours worked, and payment on an interim basis of 80% of that amount, or
9 \$442,069.20. Allen Matkins has agreed to discount its standard hourly rates by 10%
10 for this case. The work performed is described task-by-task in <u>Exhibit A<sup>1</sup></u> and is
11 broken down into the following categories:

substantial value of receivership estate assets. Because the firm has worked

- II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED.
- 4
- A. Categories and Descriptions of Work.
  - 1. <u>General Receivership.</u>

Allen Matkins' work in this category relates to the related criminal cases
against Gina Champion-Cain and Cris Torres, including communications with the
United States Attorney's Office and counsel for Gina Champion-Cain ("GCC")
regarding restitution issues and attending the hearing on restitution held on June 13,
2022. The reasonable and necessary fees for Allen Matkins' work in this category
total \$8,386.65.

12

#### 2. <u>Asset Investigation & Recovery.</u>

13 The services in this category relate generally to efforts to identify, secure, preserve, investigate and recover receivership assets. During the Application 14 Period, these services focused on (a) securing a settlement of the insurance claim 15 against the crime/theft insurance policy, (b) analyzing investments and loans made 16 by the Receivership Entities and strategies for maximizing recovery from such 17 assets, and (c) obtaining documents from third parties relevant to the Receiver's 18 19 investigation and analysis. The reasonable and necessary fees for Allen Matkins' 20 work in this category total \$5,292.45.

21

3. <u>Reporting.</u>

Allen Matkins' services in this category include assisting in preparing the Receiver's Tenth and Eleventh Interim Reports and Recommendations, which were filed on February 24, 2022 and June 14, 2022, respectively. Dkt. 755, 816. The reports includes detailed summaries of the Receiver's activities, funds recovered, real and personal property assets, restaurant and retail operations, property taxes, insurance, debt service, loans and other investments, investigation of third party claims, pending litigation, and other matters. The reports also detail the receipts and

disbursements for the receivership estate since the Receiver's appointment and
 provides her recommendations for the continued administration of the receivership.
 The reasonable and necessary fees for Allen Matkins' work in this category total
 \$4,298.85.

5

#### 4. <u>Claims & Distributions.</u>

Services rendered in this category generally relate to the claims and interests 6 of investors and creditors of the Receivership Entities. During the Application 7 8 Period, this work focused on assisting and advising the Receiver in implementing the Court-approved claims process, including advising on and addressing various 9 unique issues relating to investor and creditor claims, and gathering information 10 from counsel for investors and counsel for Chicago Title regarding settlement 11 payments made to investors on account of their losses from the Ponzi scheme. The 12 firm also communicated with counsel for Chicago Title regarding settlements with 13 investors groups, and advised the Receiver regarding such settlements and related 14 motions for approval of such settlements by this Court and the San Diego Superior 15 Court. 16

Allen Matkins assisted the Receiver in analyzing investor and creditor claims in the receivership, preparing objections to certain claims, communicating with counsel for the applicable claimants, and efforts to resolve disputes relating to claims. These efforts were successful in streamlining the ultimate motion to approve claim amounts (which is discussed below), which motion only involved two (2) disputed claims needing to be resolved out of the approximately 300 investors and numerous creditors with claims in the receivership.

Allen Matkins also advised on and assisted the Receiver in preparing her
motion (a) for approval of recommended allowed amounts of claims, (b) to resolve
disputed claims, and (c) for approval of her proposed Distribution Plan. Dkt. 807.
The motion, 35-page memorandum, detailed supporting declaration, and exhibits
were filed on May 31, 2022. *Id.*

Allen Matkins also assisted with issues related to disseminating information
 about the receivership to investors and creditors, including information provided on
 the receivership website (www.anireceivership.com). The firm also assisted in
 responding to direct inquiries from investors and creditors. The reasonable and
 necessary fees for Allen Matkins' work in this category total \$129,833.10

6

#### 5. <u>Third Party Recoveries.</u>

This portion of the Application pertains to work on potential claims against
third parties to recover amounts for the benefit of the receivership estate. Due to the
confidential nature of the legal work on these matters and the Receiver's litigation
strategy vis-à-vis third parties, the Receiver has filed a motion concurrently herewith
to file this portion of the Application under seal. The reasonable and necessary fees
for Allen Matkins' work in this category total \$22,357.80.

13

#### 6. <u>Pending Litigation.</u>

Services performed in this category include the analysis and management of 14 pending pre-receivership actions in which one or more of the Receivership Entities 15 16 are parties. Specifically, work within this category was largely devoted to the action 17 pending in Florida state court known as Westlink Dev. Co., LLC v. SunTrust Bank, Pensacola, FL Cir. Ct. Case No. 13-008139-CI, in which Westlink Development, 18 19 LLC (a Receivership Entity) and other co-plaintiffs have asserted claims against 20 SunTrust Bank for aiding and abetting a multi-million dollar Ponzi scheme allegedly 21 orchestrated by John Condo (separate from the alleged Ponzi scheme in this action). 22 This action was settled in January 2022 with approval from the Court. Dkt. 740.

Allen Matkins also assisted with issues relating to the action pending in San
Diego Superior Court known as *Luu v. The Patio Restaurant Grp., LLC, et al.*, San
Diego Super. Ct. Case No. 37-2019-00015451-CU-OE-CTL, which is a putative
class action filed by a former employee (which action is now stayed pursuant to the
litigation stay in the Appointment Order). The reasonable and necessary fees for
Allen Matkins' work in this category total \$579.15.

1

#### 7. <u>Employment/Professional Fees</u>

2 Although fee applications are a necessary component of federal equity receiverships, neither the Receiver nor her professionals charge for time spent 3 preparing their own detailed applications. Allen Matkins assisted in preparing the 4 5 Receiver's Sixth and Seventh Interim Fee Applications and with meet and confer communications with counsel for the Commission. The fee applications were filed 6 7 on February 16, 2022 and May 20, 2022 (Dkt. 746, 790) and approved on May 9, 8 2022, and October 7, 2022. Dkt. 779, 917. The reasonable and necessary fees for 9 Allen Matkins' work in this category total \$1,673.10.

10

#### 8. <u>General Clawback Claims & Settlements.</u>

11 This portion of the Application pertains to work on clawback claims against third parties and settlements to recover amounts for the benefit of the receivership 12 estate. Due to the confidential nature of the legal work on these matters and the 13 Receiver's litigation strategy vis-à-vis third parties, the Receiver has filed a motion 14 concurrently herewith to file this portion of the Application under seal. The 15 reasonable and necessary fees for Allen Matkins' work in this category total 16 \$258,772.50. To date, the Receiver has recovered more than \$8.5 million for the 17 18 receivership estate through the pursuit of clawback claims.

19

#### 9. <u>Claims Against Kim Peterson.</u>

This portion of the Application pertains to work on claims against Kim 20 Peterson and his entities to recover amounts for the benefit of the receivership 21 22 estate. Due to the confidential nature of the legal work on this matters and the 23 Receiver's litigation strategy vis-à-vis third parties, the Receiver has filed a motion 24 concurrently herewith to file this portion of the Application under seal. The 25 reasonable and necessary fees for Allen Matkins' work in this category total \$121,392.90. Kim Peterson and his entities, collectively, are the largest net winner 26 27 in the Ponzi scheme, having received more in \$12.7 million in net profits.

# 16 II. <u>THE FEES AND COSTS ARE REASONABLE AND SHOULD BE</u> 17 <u>ALLOWED.</u>

18 "As a general rule, the expenses and fees of a receivership are a charge upon the property administered." Gaskill v. Gordon, 27 F.3d 248, 251 (7th Cir. 1994). 19 20 These expenses include the fees and expenses of this Receiver and her professionals, 21 including Allen Matkins. Decisions regarding the timing and amount of an award of 22 fees and costs to the Receiver and her professionals are committed to the sound discretion of the Court. See SEC v. Elliot, 953 F.2d 1560, 1577 (11th Cir. 1992) 23 24 (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)). 25 In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties 26 27 imposed by the court upon the receiver ..., the fair value of such time, labor and 28 skill measured by conservative business standards, the degree of activity, integrity

and dispatch with which the work is conducted and the result obtained." United 1 2 States v. Code Prods. Corp., 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus 3 ultimately rests upon the result of an equitable, multi-factor balancing test involving 4 the "economy of administration, the burden that the estate may be able to bear, the 5 amount of time required, although not necessarily expended, and the overall value of 6 7 the services to the estate." In re Imperial 400 Nat'l, Inc., 432 F.2d 232, 237 (3d Cir. 8 1970). Regardless of how this balancing test is formulated, no single factor is 9 determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." SEC v. W.L. Moody & Co., Bankers (Unincorporated), 374 F. 10 Supp. 465, 480 (S.D. Tex. 1974). 11

As a preliminary matter, the Appointment Order confers on the Receiver
substantial duties and powers, including to conduct such investigation and discovery
as may be necessary to locate and account for all Receivership Assets, to take such
action as is necessary and appropriate to assume control over and preserve
Receivership Assets, and to employ attorneys and others to investigate and, where
appropriate, institute, pursue, and prosecute all claims and causes of action of
whatever kind and nature. *See* Appointment Order, Section X.

19 The Receiver promptly determined that experienced, qualified counsel was 20 necessary due to the size and complexity of the receivership estate and the Court 21 agreed, approving Allen Matkins' employment, initially on a provisional basis and 22 then on a non-provisional basis. Dkt. 126, 309. The Court also previously approved 23 the Receiver's proposal to file interim reports and fee applications on a quarterly 24 basis. Dkt. 126. As noted above, this interim application covers two quarters of 25 work.

Allen Matkins has submitted a detailed fee application which describes the nature of the services rendered. *See* **Exhibit A**. Allen Matkins has endeavored to staff matters as efficiently as possible while remaining cognizant of the complexity

of issues presented. As noted above, the request for fees is based on Allen Matkins'
 customary billing rates charged for comparable services provided in other matters,
 less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for
 6.3 hours of work (\$4,054.05 in fees).

5 The work performed by Allen Matkins was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked 6 diligently since the Receiver's appointment to preserve and protect the assets of the 7 8 receivership estate, maximize the funds available for ultimate distribution to victims, and carry out the Receiver's other duties pursuant to the Appointment 9 Order. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an 10 interim basis in recognition of the fact that its work in assisting the Receiver is 11 ongoing. Payment of the proposed 20% holdback will be sought at the conclusion 12 of the receivership. Allen Matkins' fees are fair and reasonable and should be 13 approved and paid on an interim basis. 14 **CONCLUSION.** 15 III.

16 Allen Matkins therefore respectfully request that this Court enter an Order:

- 17
- 1. Approving Allen Matkins' fees of \$552,586.50;

18 2. Authorizing and directing the Receiver to pay 80% of approved fees, or
19 \$442,069.20, from the assets of the Receivership Entities;

203.Approving Allen Matkins' costs in the amount of \$42,642.24, and

21 authorizing and directing the Receiver to reimburse such costs in full; and

22

4. For such other and further relief as the Court deems appropriate.
