Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), general counsel to Krista L. Freitag (the "Receiver"), the Court-appointed receiver for ANI Development, LLC, American National Investments, Inc. ("ANI"), and their respective subsidiaries and affiliates (the "Receivership Entities"), hereby submits this Eleventh Interim Application for Payment of Fees and Reimbursement of Expenses (the "Application"). This Application covers the six-month period from January 1, 2023 through June 30, 2023 (the "Application Period"), and seeks approval of \$651,063.15 in fees and \$28,530.15 in expenses, and an order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred (\$520,850.52) and 100% of the expenses incurred (\$28,530.15).

I. <u>INTRODUCTION.</u>

This equity receivership involves a large, complex, and wide-ranging group of enterprises and assets associated with the Ponzi scheme that is the subject of the Complaint filed by the Securities and Exchange Commission ("Commission"). The Receiver was appointed on September 3, 2019. Dkt. 6.

The ordering appointing the Receiver confers broad duties, responsibilities, and powers upon the Receiver, which are designed to allow her to secure, preserve, and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of the Receivership Entities' financial transactions, investigate and recover sums transferred to third parties, review and analyze investor and creditor claims, and maximize the amount ultimately available for distribution to investors and creditors. *Id.* The Receiver determined that experienced and qualified counsel was critical to the performance of her duties and obligations under the Appointment Order due to the size and complexity of the receivership estate. Accordingly, the Receiver engaged Allen Matkins to assist with legal issues facing the receivership estate.

This Application should be read in conjunction with the Receiver's Fourteenth and Fifteenth Interim Reports and Recommendations, filed on March 10, 2023 and

May 25, 2023 (Dkt. 966, 1002), which describe in detail the Receiver's activities during the six-month Application Period.

This Application seeks approval of \$651,063.15 in fees for a total of 1,088.30 hours worked, and payment on an interim basis of 80% of that amount, or \$520,850.52. Allen Matkins has agreed to discount its standard hourly rates by 10% for this case. The work performed is described task-by-task in **Exhibit A**¹ and is broken down into the following categories:

Allen Matkins' work has allowed the Receiver to preserve and protect the substantial value of receivership estate assets. Because the firm has worked diligently and efficiently to assist the Receiver in carrying out her Court-ordered duties, it should be compensated on an interim basis for its work.

While Allen Matkins has made efforts to ensure that its billing entries are consistent across categories, certain activities lend themselves to more than one category, or may be difficult to categorize. In any event, **Exhibit A** reflects the actual time spent by Allen Matkins personnel, and contains accurate descriptions of the services rendered.

II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED.

A. Categories and Descriptions of Work.

1. <u>General Receivership.</u>

Allen Matkins' work in this category relates to the related criminal cases against Gina Champion-Cain and Cris Torres, including communications with the United States Attorney's Office and counsel for Gina Champion-Cain ("GCC") regarding restitution issues. Allen Matkins also advised the Receiver regarding inquiries about the receivership from the media and assisted with tax questions involving the receivership estate. The reasonable and necessary fees for Allen Matkins' work in this category total \$6,341.85.

2. <u>Asset Investigation & Recovery.</u>

The services in this category relate generally to efforts to identify, secure, preserve, investigate and recover receivership assets. During the Application Period, these services focused on (a) investigating, evaluating and advising the Receiver regarding rights, remedies, and potential steps to recover on an investment made in a music festival series called Santaluz Wonderfront, and (b) analyzing and advising the Receiver on issues regarding trademarks held by the Receivership Entities. Paralegal time spent managing documents received via subpoenas and other discovery requests, and producing requested documents is also included in this category. The reasonable and necessary fees for Allen Matkins' work in this category total \$17,969.85.

3. <u>Reporting.</u>

Allen Matkins' services in this category focus on assisting the Receiver in preparing her Fourteenth and Fifteenth Interim Reports and Recommendations, which were filed on March 10, 2023 and May 25, 2023, respectively. Dkt. 966, 1002. The reports includes detailed summaries of the Receiver's activities, funds recovered, real and personal property assets, property taxes, insurance, loans and other investments, investigation of third party claims, pending litigation, and other

matters. The reports also detail the receipts and disbursements for the receivership estate since the Receiver's appointment and provides her recommendations for the continued administration of the receivership. The reasonable and necessary fees for Allen Matkins' work in this category total \$3,442.50.

4. Operations & Asset Sales.

Allen Matkins' time in this category relates to assisting the Receiver with the sale of a liquor license associated with a former Patio Marketplace restaurant. The reasonable and necessary fees for Allen Matkins' work in this category total \$344.25.

5. Claims & Distributions.

Services rendered in this category focus on disputed claims against the receivership estate and distribution of receivership estate assets. Most of the work relating to disputed claims focused on the disputed claim of CalPrivate Bank ("CalPrivate"). Allen Matkins advised the Receiver and handled settlement negotiations with counsel for CalPrivate. The firm assisted the Receiver in preparing a mediation statement and attended the mediation with Judge Goddard held on January 13, 2023, as well as follow-up settlement discussions and meetings. Allen Matkins analyzed various legal issues relating to the potential settlement, including the assignment of claims by CalPrivate to the receivership estate. This work resulted in a mediator's proposal from Judge Goddard that was accepted by both the Receiver and CalPrivate. The firm then prepared a motion for approval of the settlement and a reply brief responding to the opposition filed by Kim Peterson and his entities ("Peterson Parties"). The settlement was approved by the Court on April 24, 2023. Dkt. 995.

Allen Matkins also assisted in resolving issues relating to the disputed claims of 2Budz, the Wakefield Parties, and the investors represented by attorney Jeffrey Zinder such that distributions under the Court-approved settlement with Chicago Title could be made to them.

Allen Matkins further assisted the Receiver in analyzing the Court's order approving the Receiver's proposed treatment of claims and proposed distribution plan and in preparing to make an interim distribution of receivership estate funds. After the Peterson Parties filed a motion to stay distributions, Allen Matkins analyzed the issues, advised the Receiver, and assisted in preparing an opposition to the motion. Attorney Ted Fates attended the hearing on the motion, which was held on April 10, 2023. The motion was denied the same day. Dkt. 987. The Peterson Parties then filed an emergency motion with the Ninth Circuit, which Allen Matkins assisted the Receiver in opposing. That motion was also denied. Dkt. 996.

Allen Matkins also addressed issues and communicated with counsel for the Peterson Parties regarding their appeal of the Court's order approving the Receiver's proposed treatment of claims and proposed distribution plan.

Allen Matkins assisted with gathering information from counsel for investors and related third parties regarding settlement payments made to investors that required adjustments to be made to the Receiver's proposed allowed claim amounts and prior recovery rates for purposes of the Rising Tide distribution method. Ultimately, the Receiver was able to make an interim distribution to investors and creditors with allowed claims pursuant to the approved Distribution Plan and Notice of Interim Distributions. The total amount distributed as part of the interim distribution was \$21 million. This distribution brought the total investor recovery up to 90.92% of MIMO net losses (with some investors having received 100% or more of their MIMO net losses pursuant to Chicago Title settlements).

Finally, the firm also assisted the Receiver with issues related to disseminating information about the receivership to investors and creditors, including information provided on the receivership website (www.anireceivership.com). The reasonable and necessary fees for Allen Matkins' work in this category total \$151,461.45.

6. Third Party Recoveries.

This portion of the Application pertains to work on claims against third parties to recover amounts for the benefit of the receivership estate, but not including Clawback Claims, which have their own category and are discussed below. Allen Matkins assisted the Receiver in analyzing claims to recover on a promissory note and guaranty in favor of ANI issued by a company called Illa Designs and its owner Eric Churilla. The firm handled communications and negotiations with Mr. Churilla. When the matter could not be resolved through settlement, Allen Matkins assisted in preparing and filing a Complaint against Illa Designs and Churilla for breach of the note and guaranty. The matter did then get settled, which Allen Matkins assisted in negotiating and documenting. The firm prepared a motion for approval of the settlement, which was approved by the Court on April 18, 2023. Dkt. 993. The settlement is expected to generate a recovery of \$265,000 for the receivership estate once the Churillas complete a sale of their property located in Texas, on which the receivership estate has a recorded Deed of Trust. The reasonable and necessary fees for Allen Matkins' work in this category total \$24,879.15.

7. <u>Pending Litigation.</u>

Services performed in this category include the analysis and management of pending pre-receivership actions in which one or more of the Receivership Entities are parties. Specifically, work within this category relates to the action that was pending in San Diego Superior Court known as *Luu v. The Patio Restaurant Grp., LLC, et al.*, San Diego Super. Ct. Case No. 37-2019-00015451-CU-OE-CTL, which was a putative class action filed by a former employee (which action was stayed pursuant to the litigation stay in the Appointment Order). The action has since been voluntarily dismissed. The reasonable and necessary fees for Allen Matkins' work in this category total \$413.10.

8. <u>Employment/Professional Fees</u>

Although fee applications are a necessary component of federal equity receiverships, neither the Receiver nor her professionals charge for time spent preparing their own detailed applications. Allen Matkins assisted in preparing the Receiver's Ninth and Tenth Interim Fee Applications (each covering six months of work) and with meet and confer communications with counsel for the Commission. The fee applications were approved on February 27 and April 18, 2023. The reasonable and necessary fees for Allen Matkins' work in this category total \$2,822.85.

9. General Clawback Claims & Settlements.

This portion of the Application pertains to work on clawback claims against third parties and settlements to recover amounts for the benefit of the receivership estate. Due to the confidential nature of the legal work on these matters and the Receiver's litigation strategy vis-à-vis third parties, the Receiver has filed a motion concurrently herewith to file this portion of the Application under seal. The reasonable and necessary fees for Allen Matkins' work in this category total \$308,639.25. To date, the Receiver has recovered more than \$8.7 million for the receivership estate through the pursuit of clawback claims, which amount represents approximately 20% of the total distributions of \$43 million made by the Receiver to date.

10. Claims Against Kim Peterson.

This portion of the Application pertains to work on claims against Kim Peterson and his entities to recover amounts for the benefit of the receivership estate. Due to the confidential nature of the legal work on this matters and the Receiver's litigation strategy vis-à-vis third parties, the Receiver has filed a motion concurrently herewith to file this portion of the Application under seal. The reasonable and necessary fees for Allen Matkins' work in this category total

\$134,748.90. Kim Peterson and his entities, collectively, are the largest net winner in the Ponzi scheme, having received more than \$12 million in net profits.

A. Summary of Expenses Requested for Reimbursement.

Allen Matkins requests that the Court approve reimbursement of \$28,530.15 in out-of-pocket costs. The itemization of such expenses is summarized below by billing category.

II. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED.

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and her professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and her professionals are committed to the sound discretion of the Court. *See SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver . . . , the fair value of such time, labor and

skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United States v. Code Prods. Corp.*, 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*, 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confers on the Receiver substantial duties and powers, including to conduct such investigation and discovery as may be necessary to locate and account for all Receivership Assets, to take such action as is necessary and appropriate to assume control over and preserve Receivership Assets, and to employ attorneys and others to investigate and, where appropriate, institute, pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section X.

The Receiver promptly determined that experienced, qualified counsel was necessary due to the size and complexity of the receivership estate and the Court agreed, approving Allen Matkins' employment, initially on a provisional basis and then on a non-provisional basis. Dkt. 126, 309. The Court also previously approved the Receiver's proposal to file interim reports and fee applications on a quarterly basis. Dkt. 126. As noted above, this interim application covers two quarters of work.

Allen Matkins has submitted a detailed fee application which describes the nature of the services rendered. *See* **Exhibit A**. Allen Matkins has endeavored to

staff matters as efficiently as possible while remaining cognizant of the complexity 1 2 of issues presented. As noted above, the request for fees is based on Allen Matkins' customary billing rates charged for comparable services provided in other matters, less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for 4 5 19.50 hours of work (\$7,934.85 in fees) and \$21.20 in disbursements. The work performed by Allen Matkins was essential to carrying out the 6 Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked 7 8 diligently since the Receiver's appointment to preserve and protect the assets of the receivership estate, maximize the funds available for ultimate distribution to victims, and carry out the Receiver's other duties pursuant to the Appointment 10 Order. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an 11 interim basis in recognition of the fact that its work in assisting the Receiver is 12 ongoing. Payment of the proposed 20% holdback will be sought at the conclusion 13 of the receivership. Allen Matkins' fees are fair and reasonable and should be 14 approved and paid on an interim basis. 15 III. **CONCLUSION.** 16 Allen Matkins therefore respectfully request that this Court enter an Order: 17 18 1. Approving Allen Matkins' fees of \$651,063.15; 19 2. Authorizing and directing the Receiver to pay 80% of approved fees, or 20 \$520,850.52, from the assets of the Receivership Entities; 21 3. Approving Allen Matkins' costs in the amount of \$28,530.15, and authorizing and directing the Receiver to reimburse such costs in full; and 22 For such other and further relief as the Court deems appropriate. 23 4.
