Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), general counsel to Krista L. Freitag (the "Receiver"), the Court-appointed receiver for ANI Development, LLC, American National Investments, Inc. ("ANI"), and their respective subsidiaries and affiliates (the "Receivership Entities"), hereby submits this Thirteenth Interim Application for Payment of Fees and Reimbursement of Expenses (the "Application"). This Application covers the sixmonth period from January 1, 2024 through June 30, 2024 (the "Application Period"), and seeks approval of \$272,403.45 in fees and \$14,934.23 in expenses, and an order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred (\$217,922.76) and 100% of the expenses incurred (\$14,934.23).

### I. <u>INTRODUCTION.</u>

This equity receivership involves a large, complex, and wide-ranging group of enterprises and assets associated with the Ponzi scheme that is the subject of the Complaint filed by the Securities and Exchange Commission ("Commission"). The Receiver was appointed on September 3, 2019. Dkt. 6.

The ordering appointing the Receiver confers broad duties, responsibilities, and powers upon the Receiver, which are designed to allow her to secure, preserve, and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of the Receivership Entities' financial transactions, investigate and recover sums transferred to third parties, review and analyze investor and creditor claims, and maximize the amount ultimately available for distribution to investors and creditors. *Id.* The Receiver determined that experienced and qualified counsel was critical to the performance of her duties and obligations under the Appointment Order due to the size and complexity of the receivership estate. Accordingly, the Receiver engaged Allen Matkins to assist with legal issues facing the receivership estate.

This Application should be read in conjunction with the Receiver's Nineteenth and Twentieth Interim Reports and Recommendations, filed on May 15,

2024 and August 23, 2024 (Dkts. 1031, 1033), which describe in detail the Receiver's activities during the six-month Application Period.

This Application seeks approval of \$272,403.45 in fees for a total of 439.40 hours worked, and payment on an interim basis of 80% of that amount, or \$217,922.76. Allen Matkins has agreed to discount its standard hourly rates by 10% for this case. The work performed is described task-by-task in **Exhibit A**<sup>1</sup> and is broken down into the following categories:

Allen Matkins' work has allowed the Receiver to preserve and protect the substantial value of receivership estate assets. Because the firm has worked diligently and efficiently to assist the Receiver in carrying out her Court-ordered duties, it should be compensated on an interim basis for its work.

While Allen Matkins has made efforts to ensure that its billing entries are consistent across categories, certain activities lend themselves to more than one category, or may be difficult to categorize. In any event, **Exhibit A** reflects the actual time spent by Allen Matkins personnel, and contains accurate descriptions of the services rendered.

### II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED.

### A. Categories and Descriptions of Work.

### 1. <u>General Receivership.</u>

Allen Matkins' work in this category relates to the related criminal cases against Gina Champion-Cain and Cris Torres, including communications with the United States Attorney's Office and counsel for Gina Champion-Cain ("GCC") regarding restitution issues. The firm also advised the Receiver on the new filing requirements for the Receivership Entities under the Corporate Transparency Act. The reasonable and necessary fees for Allen Matkins' work in this category total \$4,158.00.

### 2. <u>Asset Investigation & Recovery.</u>

The services in this category relate generally to efforts to identify, secure, preserve, investigate and recover receivership assets. During the Application Period, these services focused on the preservation of Google account data for discovery purposes. The reasonable and necessary fees for Allen Matkins' work in this category total \$297.00.

### 3. Reporting.

Allen Matkins' services in this category focus on assisting the Receiver in preparing her Eighteenth and Nineteenth Interim Reports and Recommendations, which were filed on February 28, 2024 and May 15, 2024, respectively. Dkt. 1015, 1031. The reports includes detailed summaries of the Receiver's activities, funds recovered, real and personal property assets, property taxes, insurance, loans and other investments, investigation of third party claims, pending litigation, and other matters. The reports also detail the receipts and disbursements for the receivership estate since the Receiver's appointment and provides her recommendations for the continued administration of the receivership. The reasonable and necessary fees for Allen Matkins' work in this category total \$3,341.25.

4. Operations & Asset Sales.

Allen Matkins' work in this category focused on advising the Receiver with respect to the disposition of the receivership estate's interest in the Casa del Zorro hotel. The reasonable and necessary fees for Allen Matkins' work in this category total \$816.75.

### 5. Claims & Distributions.

Services rendered in this category focus on disputed claims against the receivership estate and distribution of receivership estate assets. Most of the work during the Application Period relating to disputed claims focused on the appeal of the Court's February 24, 2023 Order approving the Receiver's recommendations regarding claim amounts, resolving claim disputes, and approving the Receiver's proposed Distribution Plan ("Claims and Distribution Order") filed by Kim Peterson, Kim Funding, LLC and ABC Funding Strategies, LLC ("Peterson Parties"). Oral argument in the appeal was held on August 13, 2024.

The firm also assisted the Receiver with issues related to disseminating information about the receivership to investors and creditors, including information provided on the receivership website (<a href="www.anireceivership.com">www.anireceivership.com</a>). The reasonable and necessary fees for Allen Matkins' work in this category total \$3,935.25.

### 6. <u>Third Party Recoveries.</u>

This portion of the Application pertains to work on claims against third parties to recover amounts for the benefit of the receivership estate, but not including Clawback Claims, which have their own category and are discussed below. Allen Matkins assisted the Receiver with issues relating to the Illa Designs / Churilla settlement, which was approved by the Court on April 18, 2023. Dkt. 993. The settlement is expected to generate a recovery of \$265,000 for the receivership estate once the Churillas complete a refinance of their property located in Texas, on which the receivership estate has a recorded Deed of Trust. The reasonable and necessary fees for Allen Matkins' work in this category total \$7,647.75.

### 7. <u>Employment/Professional Fees</u>

Although fee applications are a necessary component of federal equity receiverships, neither the Receiver nor her professionals charge for time spent preparing their own detailed applications. Allen Matkins assisted in preparing the Receiver's Twelfth Interim Fee Application (covering six months of work) and with meet and confer communications with counsel for the Commission. The fee applications were filed on March 22, 2024. The reasonable and necessary fees for Allen Matkins' work in this category total \$1,559.25.

### 8. General Clawback Claims & Settlements.

This portion of the Application pertains to work on clawback claims against third parties and settlements to recover amounts for the benefit of the receivership estate. Although the vast majority of clawback claims were resolved without any action being filed, there are some where the net winners involved either refused to settle, ignored correspondence from the Receiver's counsel and other attempts to make contact, or disputed the Receiver's accounting without any documentary support. In these instances, Allen Matkins assisted the Receiver in filing and prosecuting clawback actions against the applicable net winners, including preparing complaints, amended complaints (in certain instances), discovery requests, and other pleadings.

Allen Matkins' work in this category during the Application Period focused on two clawback matters that have been fully settled – the Daniel Levene matter and the Valeiras Family Trust matter.<sup>2</sup> The firm assisted the Receiver with the steps required to complete these settlements and collect the settlement payments. The reasonable and necessary fees for Allen Matkins' work in this category total

The Receiver has previously requested that the narrative for this category of Allen Matkins' fees be allowed to be filed under seal. However, for this Application Period, all of the firm's work pertains to matters that have been fully resolved and are no longer pending, so there is no need for an under seal filing in this instance.

\$15,669.45. To date, the Receiver has recovered more than \$9.4 million for the receivership estate through the pursuit of clawback claims, which amount represents approximately 22% of the total distributions of \$43 million made by the Receiver to date. With the exception of the Kim Peterson matter discussed below, there is only one active clawback case remaining (the La Jolla Bridge / D'Agostino matter).

### 9. Claims Against Kim Peterson.

This portion of the Application pertains to work on claims against Kim Peterson and his entities to recover amounts for the benefit of the receivership estate. Due to the confidential nature of the ongoing legal work on this matter and the Receiver's litigation strategy vis-à-vis third parties, the Receiver has filed a motion concurrently herewith to file this portion of the Application under seal. The reasonable and necessary fees for Allen Matkins' work in this category total \$234,978.75. Kim Peterson and his entities, collectively, are the largest net winner in the Ponzi scheme, having received and retained approximately \$13 million in net profits from the scheme and its investors.

### A. Summary of Expenses Requested for Reimbursement.

Allen Matkins requests that the Court approve reimbursement of \$14,934.23 in out-of-pocket costs. The itemization of such expenses is summarized below by billing category.

# II. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED.

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and her professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and her professionals are committed to the sound discretion of the Court. *See SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver . . . , the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United States v. Code Prods. Corp.*, 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*, 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confers on the Receiver substantial duties and powers, including to conduct such investigation and discovery as may be necessary to locate and account for all Receivership Assets, to take such action as is necessary and appropriate to assume control over and preserve

Receivership Assets, and to employ attorneys and others to investigate and, where appropriate, institute, pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section X.

The Receiver promptly determined that experienced, qualified counsel was necessary due to the size and complexity of the receivership estate and the Court agreed, approving Allen Matkins' employment, initially on a provisional basis and then on a non-provisional basis. Dkt. 126, 309. The Court also previously approved the Receiver's proposal to file interim reports and fee applications on a quarterly basis. Dkt. 126. As noted above, this interim application covers two quarters of work.

Allen Matkins has submitted a detailed fee application which describes the nature of the services rendered. See Exhibit A. Allen Matkins has endeavored to staff matters as efficiently as possible while remaining cognizant of the complexity of issues presented. As noted above, the request for fees is based on Allen Matkins' customary billing rates charged for comparable services provided in other matters, less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for 4.10 hours of work (\$3,044.25 in fees).

The work performed by Allen Matkins was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked diligently since the Receiver's appointment to preserve and protect the assets of the receivership estate, maximize the funds available for ultimate distribution to victims, and carry out the Receiver's other duties pursuant to the Appointment Order. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an interim basis in recognition of the fact that its work in assisting the Receiver is ongoing. Payment of the proposed 20% holdback will be sought at the conclusion of the receivership. Allen Matkins' fees are fair and reasonable and should be approved and paid on an interim basis.

### III. **CONCLUSION.** 1 Allen Matkins therefore respectfully request that this Court enter an Order: 2 3 1. Approving Allen Matkins' fees of \$272,403.45; Authorizing and directing the Receiver to pay 80% of approved fees, or 2. 4 \$217,922.76, from the assets of the Receivership Entities; 5 Approving Allen Matkins' costs in the amount of \$14,934.23, and 6 3. authorizing and directing the Receiver to reimburse such costs in full; and 7 4.
